Ms. Williams and Edwards, I am writing to let you know that I have reviewed the affidavits that you provided which essentially allege that Parker County utilized non-certified voting machines in the November, 2020 election. After investigating your concerns, I have determined that the voting machines that were used in Parker County were approved and certified by the Secretary of State of the State of Texas for use in the election and were, therefore, in compliance with Texas law. While I am not required to do so, in the interest of transparency, I have decided to send you the documentation which shows the above, PDFs of which are attached. I also received certification/approval information for the system that we will be using in Parker County moving forward, copies of which are also attached. Parker County Elections Administrator Cricket Miller was very helpful in my efforts to look into your concerns and provided me with their documentation. She verified for me that I could provide you with the documentation attached, both with regard to your allegations in the affidavits as well as with potential concerns that you may have moving forward. I cc'd her to this email so that you would have her contact information in the event that you had any additional or follow up questions.
